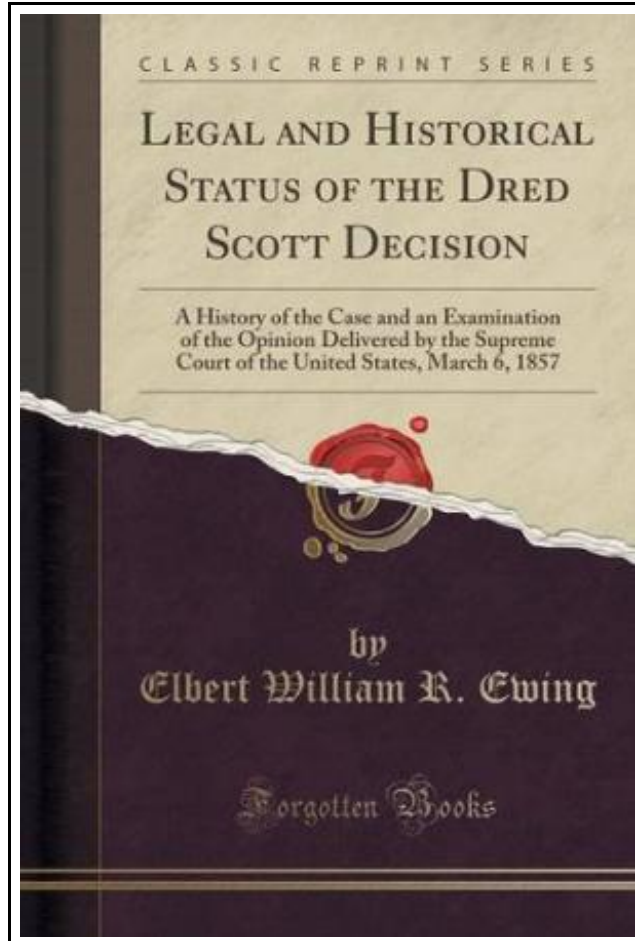

This is the first reported case in the United States where the nullity of an unconstitutional law was discussed before a judicial tribunal. It is the first great American precedent. In 1803 the Supreme Court of the United States held that, The powers of the legislature (Congress) are defined and limited; and, that those limits might not be mistaken or forgotten, the Constitution is written. This is the first instance in which an act of Congress was held unconstitutional, and the first in history wherein a court called in question an act of a national legislature.
